These Terms and Conditions ("Terms", "Terms and Conditions") govern your relationship with http://www.nuclear-21.net website (the "Service") operated by LISTO bvba / Nuclear-21 ("us", "we", or "our").

Please read these Terms and Conditions carefully before using the Service.

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you may not access the Service.

#### **PURCHASES**

# **PRIVACY POLICY - TERMS AND CONDITIONS**

#### SUBSCRIPTIONS

Some parts of the Service are billed on a subscription basis ("Subscription(s)"). You will be billed in advance on a recurring and periodic basis ("Billing Cycle"). Billing cycles are set on a annual basis.

At the end of each Billing Cycle, your Subscription will automatically renew under the exact same conditions unless you cancel it or LISTO bvba / Nuclear-21 cancels it. You may cancel your Subscription renewal either through your online account management page or by contacting LISTO bvba / Nuclear-21 customer support team.

A valid payment method, including PayPal, is required to process the payment for your Subscription. ### FREE TRIAL
